## Message from the Board President

Governor Gavin Newsom has officially signed Assembly Bill 1501, the California Physician Assistant Board's sunset review bill. As President of the Physician Assistant Board (PAB), I had the honor of testifying before the Joint Sunset Oversight Review Hearing of the Senate Business, Professions, and Economic Development Committee on March 24, as well as on June 30, 2025. This legislative milestone marks a significant

development for the physician assistant community. The bill extends the regulatory authority of the Board until January 1, 2030, ensuring that the Board can continue its licensing and enforcement functions to protect the public.

The sunset review bill also increased the Board's application fee, initial license fee, and delinquency fee. The bill does not increase the biennial license renewal fee, but gives the Board authority to increase that fee to an amount not to exceed \$500, if necessary. Any change to these fees would be accomplished by adopting a regulation after stakeholder review and comments. Also, amendments were added to the bill that, as of January 1, 2026, the supervising physician-to-PA ratio will increase from 1:4 to 1:8 across all practice settings, and the bill expresses the Legislature's intent to conduct a comprehensive review of practice agreement structures at its next sunset review.

Lastly, I want to express my heartfelt gratitude to Rozana Khan, the Board's Executive Officer, and her staff for their excellent work compiling the sunset review report. I also appreciate the participation of, and comments provided by, the public during the entire sunset review process.

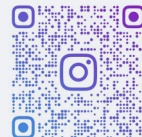

## "Three Day Rule" for Opioid Use Disorder Treatment

Under federal and state law (**21 CFR §1306.07(b)** and **Health & Saf. Code, § 11158**), authorized practitioners who are not specifically registered with the federal Drug Enforcement Administration to conduct a narcotic treatment program (NTP) may dispense on an emergency basis Schedule II narcotic medication (e.g., methadone) to patients for the purpose of initiating maintenance treatment or detoxification treatment (or both).

Key Requirements of the Rule:

- Practitioners may dispense up to a three-day supply of Schedule II narcotic medication while referral to opioid treatment is being arranged.
- Not more than a three-day supply may be dispensed to one person for one person's use. This emergency treatment may not be renewed or extended.
- The rule is intended as a short-term emergency bridge until the patient can be admitted to a licensed NTP.

The Three Day Rule represents one pathway for practitioners to dispense Schedule II medications to initiate treatment for opioid use disorder (OUD). For more information about the Three Day Rule and other pathways to treat OUD, see the additional resources at the bottom of this notice.

## Name and Address Changes

It is very important that the Board has accurate name and address information on file, should the Board need to contact its licensees or applicants. Instructions for submitting name and address changes are available on the **PAB website**.

Licensees are required by law to notify PAB within 30 days if they change their name or address of record. The Enforcement Division cites and fines physician assistants who fail to comply with this requirement.

Submit the **Change of Address Form (PDF)** to the Board by mail, fax, or email. Addresses are updated instantaneously when completed using your **BreEZe account**.

## Cures Reporting New Law Effective January 1

Effective January 1, 2026, **Assembly Bill (AB) 82** prohibits health care providers from reporting a prescription for or the dispensing of testosterone or mifepristone to the Controlled Substance Utilization and Evaluation System (CURES) or to the Department of Justice's contracted prescription data processing vendor, currently Bamboo Health. Existing records for testosterone or mifepristone will be removed from CURES on or before January 1, 2027. ## Licensing Activity

The Board processes applications in the order they are received. **Please allow the Board 30 days to complete an initial review of the application before contacting the Board for an update.** To view current processing times for applications submitted to the Board, please visit [www.pab.ca.gov/applicants/timeframes.shtml](http://www.pab.ca.gov/applicants/timeframes.shtml). As a friendly reminder, please do not wait till the time of renewal to update your address of record (mailing address). Pursuant to Title 16, California Code of Regulations, section 1399.511, licensees are required to report in writing to the Board any and all changes of their mailing address within 30 days from the date the change occurred. Failure to update the mailing address may result in the licensing system mailing correspondence to an inaccurate mailing address and may cause a delay in renewal.

## New Regulatory Package

On August 4, 2025, the Office of Administrative Law (OAL) approved the Physician Assistant Board's regulations related to Initial License Fee codified at California Code of Regulations, title 16, section 1399.550. The regulation became effective on October 1, 2025.

The regulation increases the initial license fee from two hundred dollars (\$200) to two hundred and fifty dollars (\$250).

<b>AB 82</b> Health care: legally protected health care activity	Ward, Chapter 679, Statutes of 2025	Health and Safety Code section 11165	Among other things, this bill prohibits prescribers from reporting prescriptions for testosterone or mifepristone to CURES, the California Department of Justice, or a contracted prescription data processing vendor.
<b>AB 260</b> Sexual and reproductive health care	Aguiar-Curry, Chapter 136, Statutes of 2025	Business and Professions Code sections 601, 687, 850.3, 2519, 2761, 2878, 4076, 4318, and 4521	This urgency bill prohibits healing arts practitioners from being subject to civil, criminal, or disciplinary action solely on the basis that the practitioner prescribed a drug used for medication abortion. It allows pharmacists to dispense medication abortion drugs without the name of the patient, prescriber, or the name and address of the pharmacy on the prescription label. This bill also contains provisions that protect the use of medication abortion that affect the Department of Public Health and the Department of Health Care Services. <b>This was an urgency bill that went into effect immediately upon signing, on September 26, 2025.</b>
<b>AB 447</b> Emergency room patient prescriptions	González, Chapter 363, Statutes of 2025	Business and Professions Code sections 4068 and 4427.2	This bill allows a prescriber to dispense an unused quantity of a dangerous drug acquired by a hospital pharmacy to an emergency room patient when they are discharged, if the drug was administered from single patient use multi-dose packaging and can be self-administered by the patient. This bill also provides that the drug must have been ordered and administered to the emergency room patient and must be necessary for the continued treatment of the patient but may not be a controlled substance. Additionally, this bill adds to the circumstances of when an exempt from licensure automated unit dose system used to provide medication to patients can be utilized.

<b>AB 489</b> Health care professions: deceptive terms or letters: artificial intelligence	Bonta, Chapter 615, Statutes Of 2025	Business and Professions Code sections 4999.8 and 4999.9	The healing arts practice acts often prohibit the use of specific terms, letters, or phrases by unlicensed individuals that misleadingly indicate or imply the individual is licensed. For instance, the use of "Dr.," "M.D.," or "doctor" is generally prohibited unless the person holds a physician's and surgeon's certificate, because the terms indicate or imply the person is licensed to practice medicine. (Bus. & Prof. Code, section 2054.)  This bill prohibits the use of specific terms, letters, or phrases that are reserved for licensees in the healing arts practice acts in the advertising or functionality of artificial intelligence systems. Healing arts boards within the Department of Consumer Affairs may pursue an injunction, restraining order, or other remedy, such as an administrative citation, against a person or entity who develops or deploys such a system.
<b>AB 1037</b> Public health: substance use disorder	Elhawary, Chapter 569, Statutes of 2025	Civil Code section 1714.22  Health and Safety Code sections 1797.197, 11372.7, 11834.01, 11834.026, 11834.26, 11999, and 11999.1, and repeal 11999.2	This bill eliminates specified requirements, such as mandatory training, for any person to legally possess and use opioid antagonists and shields individuals from civil or criminal penalties if they administer opioid antagonists in good faith. This bill also explicitly protects licensed health care providers who prescribe opioid antagonists from professional review and criminal prosecution. Additionally, this bill protects those providers from liability in civil actions related to any person who administers the opioid antagonist in good faith and not for compensation.
<b>AB 1501</b> Physician assistants and podiatrists	Berman, Chapter 194, Statutes of 2025	Business and Professions Code sections 3502.35, 3504, 3504.2, 3509, 3513, 3514.1, 3516, 3521.1, 3521.2, 3523, and 3537.45	This is the sunset bill for the Physician Assistant Board and extends the Board's sunset date until January 1, 2030. This bill includes various necessary updates to reflect that the Board does not approve PA training programs. This bill increases the number of physician assistants whom a physician and surgeon may supervise at any one time to 8. This bill establishes a \$60 application fee, a \$250 initial license fee, and a \$300 biennial license renewal fee. The bill authorizes the Board to increase the application fee to not more than \$80, the initial license fee to not more than \$500, and the biennial license renewal fee to not more than \$500. The bill expresses the Legislature's intent to review how practice agreements are utilized in other states, evaluating their potential benefits or detriments to patient care, workforce efficiency, and regulatory oversight. The bill also makes several other technical changes identified in the Board's sunset report.
<b>SB 497</b> Legally protected health care activity	Wiener, Chapter 764, Statutes of 2025	Civil Code section 56.109  Health and Safety Code section 11165  Penal Code section 1326	This bill, among other provisions, prohibits healing arts practitioners from cooperating with any inquiry or investigation by individuals or departments from another state or a federal law enforcement agency, to the extent permitted by federal law, that would identify an individual seeking or obtaining gender-affirming health care that is lawful in California. It also prohibits state or local agencies from knowingly providing CURES data or knowingly assisting in an interstate investigation or proceeding seeking to impose civil, criminal, or disciplinary liability based on another state's laws for the provision or receipt of legally protected health care activity. Individuals who violate these provisions are guilty of a misdemeanor.

## Sunset Bill

Assembly Bill (AB) 1501 has been signed by the Governor, extending the Board's operation for another four years through January 1, 2030. Here are the major changes of AB 1501 that affect our Board:

- **Board Extension:** Extends the Board's operation until January 1, 2030.
- **Training Programs:** Updates statutes to reflect that PAB does not approve Physician Assistant training programs, aligning oversight with national accreditation bodies.
- **Fee Updates:**
  - Application Fee: Set at \$60 and may not exceed \$80 (previously \$25).
  - Initial License Fee: Set at \$250 and may not exceed \$500 (previously \$200).
  - Biennial Renewal Fee: Set at \$300 and may not exceed \$500.

- Delinquency Fee: Set at \$75 (previously \$25).
- Letters of Endorsement/ Good Standing/ Verification: Set at \$50 (previously \$10).

- **Supervision Ratio:** Increases the maximum number of physician assistants a physician may supervise from four to eight in all practice settings.
- **Practice Agreements:** Expresses legislative intent to review the structure and utility of practice agreements. This provision is a statement of legislative intent and does not create additional duties or workload for the Board.





## Administrative Actions–Citations

A citation is an administrative action by which the Physician Assistant Board may address relatively minor violations of the Physician Assistant Practice Act or the Board's regulations that would not necessarily warrant discipline in order to protect the public. Citations ARE NOT disciplinary actions but are matters of public record. Citations remain on a licensee's file for five years and are then purged. By law, payment of a fine is considered satisfactory resolution of all violations contained in the citation.
