

Title 16. Professional and Vocational Regulations  
Division 13.8. Physician Assistant Board**

**ORDER OF ADOPTION**

Amend Section 1399.550 of Article 5 of Division 13.8 of Title 16 of the California Code of Regulations to read as follows:

**§ 1399.550. Physician Assistant Fees.**

The following fees for physician assistants are established:

- (a) The application fee shall be \$25.00.
- (b) The fee for an initial license shall be ~~\$200.00~~\$250.00.
- (c) The fee for renewal of a license shall be \$300.00.
